Dear Artist:

Thank you for your interest in applying to be a member of Shadow Mountain Gallery Artist's Co-op. Founded in 1990, the gallery has approximately 40 artists at any given time representing a variety of fine art and fine craft media. This is an artist-owned gallery. All of the work of running the gallery is carried out by the artists.

Jury sessions are held two times a year, but more often if a vacancy arises. Applicants will be notified of the next jury session.

Applicants should bring 4 - 6 representative examples of the work they would plan to show if accepted. Two dimensional pieces should be presented in a professional manner with quality dry mounting and/or matting and framing. All decisions are based on viewing the actual work.

Major points in Exhibition and Sales Agreement:

- Initial minimum 12 month commitment is required with a 6 month probation period.
- If you terminate your association with the gallery, prior to your one year commitment, you will be required to pay the remainder of your term (rent equivalent) either in cash or your artwork.
- Monthly rental fee: \$45 per month for a full space (wall space for 2d work or shelf space for 3d;) or \$22.50 for a 1/2 space, is due monthly by the 1st of each month, and may be paid in advance.
- Artist maintains up-to-date inventory
- Gallery insures for loss and damage to work
- \$75 membership fee
- Work requirement is according to the rent and the hours they contract for. Each artist must work one day per month and may be requested to add an additional day during the calendar year.
- SMG retains a 35% commission
- Artists are paid by the 25th of the month for the previous month's sales. Gallery collects and remits sales tax
- All work displayed must be of quality consistent with the work that was juried
- Exclusivity requested for a 5-mile radius

Additional fees:

- \$10 annual Internet fee. Artist name and medium are listed on the gallery web site.

Other:

- Serve on a committee of choice (i.e., Jury, Display, Marketing, Special Events)
- Attend a one day training session before working in the gallery on your own
